A Project funded by the Victims and Survivors Service to address Emerging Critical Needs including Social Isolation to Victims and survivors impacted as a result of the ongoing COVID 19 Pandemic.

The Ely Centre is a Registered Charity specialising in the provision of multi-disciplinary support services for civilians, security force personnel and their families, who have experienced bereavement and injury as a result of the "Troubles".

The Ely Centre is committed to serving innocent victims and survivors, ex service personnel, their families and carers by providing evidenced based outcome focused treatments, prevention and support services that address issues of declining psychological, physical health, social and financial difficulties arising as a result of the troubles.

The Organisation formed by relatives of the bereaved and injured of 1987 Enniskillen Poppy Day Bomb which claimed the lives of 12 innocent civilians and injured scores more, has over the last three decades developed into a proven centre of excellence in providing care and support for victims and survivors of the Troubles and their families.

## **Role description**

We see this role to have a range of priorities:

- To Provide engagement and 1on1 support to referred clients through Telephone and Online Support to those Impacted as a result of COVID 19
- To deliver 80 one on one sessional support hours ongoing need assessment/ reporting of Victim/survivor Needs arising as a result of COVID 19 and onward referral.
- To Assist in the delivery of Social Isolation Support Programmes ( Inc: Virtual Support Programme and Food/ Emergency Supplies Distribution)
- To inform Victims about additional support services offered by TheEly Centre to encourage a holistic approach.
- Attend team meetings with Director of Services and Health & Wellbeing Team and/or other relevant Ely Centre staff periodically throughout the project term
- Liaise with Director of Services or Health & Wellbeing Teams immediately should a problem arise, relating to the well-being of a Client or if identified that they may need any other support or referral pathway.
- Be prepared to deliver a flexible service for The Ely Centre to enable us to meet the needs of our client base.

**Role Location:** In adherence with current Govt Guidelines we anticipate this position to be based Remotely with an office base as either the Enniskillen or Markethill Office (dependent upon successful applicant)
